Looking to the future



Shuswap Lake General Hospital plays a vital role in the provision of healthcare to our communities. The hospital is inextricably linked to the tertiary levels of care provided in Vernon, Kelowna and Kamloops hospitals as part of Interior Health Authority (IHA).

With the increase in population, especially the 65 and older age group, Shuswap Lake General Hospital (SLGH) will require ongoing community support. This will keep up with the services to meet the increased demand as well as keeping the CT and Diagnostic Imaging Services (DI) up to date with everchanging technology.

The recent 24 million dollar expansion

of the ER and diagnostic imaging departments was just the beginning; improvements have included modernization of the pharmacy and lab services. Future plans for upgrades to the hospital include the operating room(OR) and the intensive care unit(ICU) facilities. Other changes include how home care services are delivered, including caring for the senior populations and increases in the number of day surgeries. All these changes diminish the need for more beds required in the hospital; thereby reducing cost and the potential for patients to contract diseases.

President's message




Dr. A. Sellers, Head of Anesthesia, shows how positioning cushions can allow patients with breathing difficulties to be safely intubated during surgery.



Dr. Janice Journeau demonstrates the gamma probe, used in early detection of cancer and which allows for non-invasive cancer treatment procedures.



The tympanometer is used to quickly identify fluids in the ear that can affect hearing and learning disabilities in children. Early diagnoses allow for intervention and corrective procedures.



Dr. Scott McKee demonstrates the Vscan Pocket Ultrasound used for patients with cardiopulmonary conditions, a rapid-access diagnostic tool now used daily.



This positioning system supports patients during spinal procedures. Previously a nurse would have to support the patient during a procedure. OR nurse Susan Schmidt recognized the benefits of using such a unit for both patient and medical staff safety.



During the past decade, the Shuswap Lake General Hospital has been undergoing significant reconstruction and replacement of equipment, intended to make the hospital more efficient and provide the ability to acquire more detailed data and analysis. This will provide improved outcomes for patient recovery and well-being along with patient safety and comfort in mind.

Medical teams appreciate the advancements that have taken

place; however, this is just the beginning. There are at least two additional phases of development to come, involving the OR, ICU departments and home care services including seniors' care. IHA will continue to be responsible for infrastructure and annual hospital operating costs; in turn, the Shuswap Hospital Foundation will be required to support IHA with priority equipment needs incorporating the latest advancements in technology. The creation of the **Foundation's Perpetual Health Legacy Fund** is designed to ensure that funds can be raised in the next few years to adequately finance the priority equipment projects. The fund at present stands at \$106,000.00; the goal is to reach **1 million dollars** over and above the average annual equipment needs. We look for your continued support in the quest to deliver the highest standards of care for all.

Caring for the Community

Homecare & community care initiatives



- There are some 450 medical employees serving the community, including home care.
- The hospital annual budget is \$42 million.

At any given time, some 450 clients own care and needs so that they are taken care of and 40-50 medical personnel provide services for patients in their homes around the Shuswap.

Community care services manager 21-year veteran Renee Roberge is very proud of the role her team plays. Sadly, we will be losing her and will miss her cheer and competence. We wish her well for the future. She states the home care mandate very clearly: "Home is best."

It's our goal to teach/support our clients and families to manage their are in their own environment for as long as safely possible.

"We respect our clients' rights to make choices and we offer options to assist them in their decision-making. If needed, we are able to augment the clients' and families' self management with IH home supports, including access to adult day programs, palliative care, ambulatory nursing clinic services and referrals to other IH or community-based services."



Community integrated health services

Report by Kirstine Hill, Administrator

Our focus is to provide care in the community to improve the quality of people's lives while keeping them out of acute care and avoiding ER visits at the hospital. Accomplishing that reduces the need for more beds at the hospital-the most expensive place for people to receive care. Target areas of support for those at risk include the following:

Breathe Well Program: For patients with Chronic Obstructive Pulmonary Disease (COPD), one of the leading causes of death in Canada with rates continuing to rise. This requires a multidisciplinary team support including respiratory therapists, physiotherapists, GPs and specialists, resulting in fewer and shorter hospital admissions. There

are two new respiratory therapists on the team.

Mental Health and Substance Use Program: By focusing on community resources, the program is expected to reduce the use of more expensive but more effective points of care such as the ER. The program will help those with severe mental illness to access care from a general practitioner. The equivalent of 1.5 fulltime staffing positions have been added including social work and life skills workers.

Palliative Care: Last year a community forum was held to get input for end-of-life services. Modifications for services are already in place, including a multidisciplinary group of physicians, IH staff and hospice. A



full-time palliative care coordinator has been hired to support clinical care and education. This will help people at the end of their lives to stay at home or access palliative care at Bastion Place rather than be admitted to hospital.

Did you know?

- The ER serves over 17,000 people each year.
- There are over 60,0000 patients treated at the hospital as critical care patients; this includes day surgeries, diagnostic imaging exams, therapy treatment, ambulatory care and newborns.

Caring for our seniors

Community integrated health services: The

Foundation is frequently asked why there are not more beds at the hospital. Not only does it cost more than a thousand dollars a day to keep someone in the hospital; but more importantly, for many patients this isn't the best way

to care for their particular health needs.

Kirstine Hill, CIHS Administrator for the North Okanagan region, reports that depending on needs, there are a number of facilities that provide the appropriate levels of care. A nurse will undertake an assessment based on a referral.

Once the care needs of the client are determined, he/she is assigned a level of care (complex or assisted living). The client and family identify their location choice. Depending on availability, alternative locations may be required until an opening is available at the preferred location.

Facilities operated by Interior Health include Bastion Place, in which there are a number of palliative care rooms, including a family room and patio area for the family to be together. Interior Health also funds beds at Hillside Village, Mount Ida Mews, and Piccadilly Care Centre, all complex care facilities. Pioneer Lodge is owned and operated by the Good Samaritan Society and offers assisted living care.

Except for Bastion Place, the care facilities are also available for clients who pay for private care.



Ways to leave a legacy

"When you have a life threatening disease the journey is like a yo-yo. In my case, I was diagnosed with Stage IV metastatic melanoma. One day I woke up with severe headaches, and these continued for a number of days. The worst thoughts came into my mind. I had been warned that the disease tries to metastasize to the brain, which is typically terminal. Fortunately in Salmon Arm we have an accessible CT machine and department which is available 24 hours a day; and I was able to get in and have my CT scan within a very short time. In my case, I was fortunate there was no metastasis at that time. But I do think of those individuals where a week, a day, an hour, or a matter of minutes makes a difference to help get started on diagnosis, treatment or surgery. Our CT machine and the department help with proximity and urgency, but they need our support and they have mine."
